Goals and objectives of the organization

The "Social Justice" (SJ) is a non-governmental organization based in Yerevan. The Organization was established upon the General Assembly of the Organization on 15th February of 2004.

Since, Social Justice NGO has got very involved in the rehabilitation activities for juvenile and adult prisoners, both inmate and released.

The mission of the organization is restoring social justice within the society.

Furthermore, The Organization aims to invest in criminal justice reforms in the Republic of Armenia (in particular, Reforms in Penitentiary System and establishing the National Probation Service).

It is also among Organizations' activities to implement reforms with regard to detained persons and convicts, helping them in integrating as full members of the society.

The organization consists of professionals in psychology, penitentiary law, human rights, as well as an ad hoc team of experts for addressing each individual issue in the sphere.

The Organization is the Armenian member of the European Organization for Probation (CEP). Within the framework of implementation of our programs, the Organization has established long-term working relationships with different state Bodies and Agencies such as the Ministry of Justice, Penitentiary Service, Police of the Republic of Armenia, Ministry of Labor and Social Issues (in particular, with State Employment Agency), Ministry of Education, The Ministry of Defense, the Ombudsman's office.

Also relationships were established with international organizations such as, Organization for Security and Cooperation in Europe (OSCE), Penal Reform International (PRI), USAID/Counterpart- Armenia, OSIAF-Armenia.
