Special conditions

article 1 — Purpose

- The purpose of this Contract is the award of a grant by the Contracting Authority to finance the implementation of the action entitled: "Access to information and investigative journalism for better informed citizens" (the 'Action') described in Annex I.
- The Beneficiaries shall be awarded the grant on the terms and conditions set out in this Contract, which consists of these special conditions (the 'Special Conditions') and the annexes, which the Beneficiaries hereby declare they have noted and accepted.
- The Beneficiaries accept the grant and undertake to be responsible for carrying out the Action.

crticle 2 — Implementation period of the Action

- This Contract shall enter into force on the date when the second of the two Parties signs.
- 2) Implementation of the Action shall begin on the first day of the month following the date on which the trirst instalment of pre-financing is paid by the Contracting Authority.
- The implementation period of the Action, as laid down in Annex I, is 20 months.
- The execution period of this Contract shall end when the payment of the balance is made by the Contracting Authority and, in any event, at the latest 18 months after the end of the implementation period as stipulated in Article 2.3 unless postponed in accordance with Article 12.5 of Annex II.

rticle 3 — Financing the Action

- The total eligible costs are estimated at EUR 390,000.00, as set out in Annex III.
- 2 The Contracting Authority undertakes to finance a maximum amount of EUR 343,200.00.
 - The grant is further limited to 88% of the total eligible cost of the Action specified in paragraph 1.
 - The final amount of the Contracting Authority's contribution shall be determined in accordance with Articles 14 and 17 of Annex II.
- Pursuant to Article 14.7 of Annex II, 0.5% of the final amount of direct eligible costs of the Action established in accordance with Articles 14 and 17 of Annex II, may be claimed as indirect costs.

rticle 4 — Reporting and payment arrangements

- Payments shall be made in accordance with Article 15 of Annex II option no. 2 as set out in Article 15.1
 - Initial pre-financing payment: EUR 93.000,00.
 - Further pre-financing payments(s): EUR 215.200.00 (subject to the provisions of Annex II).
 - Balance of the final amount of the grant: EUR 35,000 (subject to the provisions of Annex II).
- The reporting period for the project is as follows:
 - For the first 12 months of implementation the reporting period is reduced to 6 month. A first interim (Narrative and Financial) report will be submitted after 6 months and a second interim report will be submitted after 12 months of implementation.
